

#### **International Association of Women Police 2014 Awards Program is open for nominations**

Visit the website at <a href="www.iawp.org">www.iawp.org</a> for instructions and the nomination form. All nominations are submitted electronically online through the website. The deadline for nominations is April 28, 2014.

Your submission must be in English. The writeup is limited to approximately 4 type-written pages even though the submission form shows a single write-up field. (You may want to type out your submission in a word processor, then cut and paste the text into the fields.) We cannot accept photos, newspaper articles, or similar material at this time.

**SELF Nominations** <u>are not accepted</u> and will be returned without action. A superior official or senior officer must nominate you.

A nominee (person, name, individual) can be submitted for consideration in only a single category. Submitting a nominee for more than one category will cause all nominations for that individual to be returned without action.

**Criteria for each award** are shown below in each award category. Nominations not meeting criteria are returned without action.

#### Officer of the Year

This category is awarded to an officer who, by her overall service and accomplishments throughout her

career, distinguishes herself in the four areas of leadership, community service, mentoring and excellence in performance.

#### **Mentoring Award**

This category is awarded to an officer, who distinguishes herself with her support and assistance to women in law enforcement, development of programs or policies favorable to women, serving on committees or organizations that review women's issues.

#### **IAWP Leadership Award**

Awarded to an officer who distinguishes herself by superior accomplishments or continuing, long term involvement, using leadership skills that encompass but are not limited to problem solving, planning, organizational, communication and/or administrative which make a significant contribution within the agency or the law enforcement mission.

#### **Community Service Award**

This category is awarded to an officer who distinguishes herself by superior accomplishments through developing, designing, implementing and participating in programs involving communities, which include neighborhoods, school, community meetings, and businesses.

#### **Civilian Achievement**

Awarded for outstanding achievement by a civilian woman that has gone above and beyond to support,



## Breaking a Detention, Conducting Consent Search at Roadside

It is recommended that you read *R. v. Jacobs*, 2013 NLTD(G) 116, which is a decision from Judge Goodridge dated July 29, 2013 from the Supreme Court in Corner Brook. It explains how to successfully break a detention after a traffic safety stop, continue questioning the driver and to conduct a consent search of a vehicle.

In this particular case, the driver was stopped for an alleged violation of the HTA. When the police had the vehicle pulled over, they observed several indicators common among drug couriers (paragraph 18 of the decision). The officers didn't have the grounds to engage in an investigative detention for the CDSA, so they decided to break the HTA detention. All documents were returned to the accused, he was advised that no ticket would be issued and that he was free to go. The officers

stepped away from the vehicle. The driver was then asked if he would agree to answer some questions.

The Court made the following findings:

The driver was neither physically or psychologically detained at the conclusion of the HTA traffic stop.(paragraphs 31-35)

The driver provided a voluntary consent to search the vehicle-the search request was made, the officers disclosed they were searching for drugs, and that if discovered he would be arrested. He was also advised the consent could be withdrawn at any time. (paragraph 40)

Since there was no detention at the conclusion of the HTA stop, the police did not have to provide the accused with his rights to counsel when they questioned him and asked him if they could search the vehicle. Once the drugs were found and an arrest was made, rights to counsel were properly given.


The RCMP's annual Klondike Night is Friday, February 28, 2014.

### 21st AWLE Annual Training Conference in Charlottetown, PEI tremendous success

The Atlantic Women in Law Enforcement (AWLE) 21st annual training conference held in Charlottetown, PEI, from November 5-8, 2013 was a tremendous success, with approximately 90 delegates in attendance. The presentations were informative and valuable and the conference provided excellent opportunities for networking for those in attendance. The theme of the conference was "Beyond HERoes and HERizons" and was cohosted by members of the RCMP, Charlottetown Police, and Summerside Police, led by co-chairs Cst. Tara McBride and Cst. Louanne McQuaid.

Judge Nancy Orr was the keynote speaker. Judge Orr was appointed a Judge of the Provincial Court of PEI in 1995; the first female judge to be appointed. She spoke of her legal career and how she remains active in various legal associations as well as in her community.

Over the three day training conference, other speakers included Parry Aftab, internet privacy and security and Executive lawyer Director StopCyberbullying.org. Her presentation on cyberbullying, sexting, and sextortion provided some practical aspects of investigating cybercrime. Dr. Marnie Wood is a Forensic Pathologist and Medical Examiner in the province of Nova Scotia who presented on Medicolegal Death Scene Investigations and preserving and collecting evidence. Caroline Leblanc is a Clinical Psychologist and gave a presentation on mental health issues and how, as peace officers, we can transition "from survivor to resilient" in our careers. Cst. Natasha Jamieson, a member of the RCMP in Halifax, conducted an informative and interesting presentation on Human Trafficking and how it impacts society on a local to global scale. Anne Marie Hagan is from Newfoundland and Labrador and her story of how she forgave the neighbour who murdered her father with an axe was inspiring and riveting. Her journey from tragedy to forgiveness demonstrates the strength and versatility of the human spirit and instills hope. New Brunswick Crown Attorney Karen Lee Lamrock and New Brunswick RCMP Constable Tonia Williams presented the case study of a large scale international child pornography investigation and successful prosecution that took place in rural New Brunswick, where the accused received a fifteen year jail sentence. Stephanie Knickle-Currie, Imotion Pilates Fitness & Consulting owner/operator, led conference delegates through a high

energy workout and spoke of the importance of maintaining a healthy body. The case study of the abduction and homicide of Victoria (Tori) Stafford was presented by Detective Inspector Mike Bickerton of the OPP and Detective Constable Karen Overbaugh of Woodstock Police Service. The outcome of the investigation made an impact not only on the people involved in the case but the community that supported that investigation from beginning to end.

These presentations provided delegates with a great deal of knowledge that will assist in their professional careers and personal lives.

The highlight of the week was the Awards Banquet hosted by local radio personality Kerri Wynne MacLeod with delegates and dignitiaries including representatives of the Royal Canadian Mounted Police and municipal police departments. The following awards were presented:

#### Officer of the Year – Constable Katie Roy, Saint John Police, New Brunswick

Cst. Katie Roy has immersed herself in her job with the Saint John Police Force, and with her community on several levels. She maintains an exceptionally high level of tactical and knowledge proficiency in policing and challenges coworkers to improve, while volunteering her time to train and organizing others to do so as well. She displays a great deal of empathy for her community, and women's issues in particular. She coaches and participates in various sports and activities and has inspired a number of employees to modify their lifestyles for the positive. She routinely mentors other police or civilian employees and approaches this with compassion and willingly gives of herself to help others feel better and therefore contribute to the community and is a 'role model' for young women, police and civilian. Cst. Roy routinely goes out of her way to provide excellence in service and leadership, whether on a routine call-forservice, or at a high-risk warrant service as a member of the advanced tactical unit.

Cst. Roy typifies not only what is best about women in policing, but what is best about policing and for this reason she is the very deserving recipient of the Officer of the Year Award.



#### Community Service Award - Constable Jade Kean, Newfoundland and Labrador RCMP

Cst. Jade KEAN is assigned to the Northern Labrador community of Happy Valley-Goose Bay, where she is responsible for policing several diverse aboriginal groups including Inuit, Innu and Metis. She volunteers at the local SPCA shelter and often fosters multiple stray dogs at her home. Jade realized that something more had to be done to help the chronic problem of stray dogs in the community and through her research on stray dog problems, learned about a program called "Dogs with No Names". The program was developed by Dr. Judith Samson-French and involved inserting contraceptive implants under the skin of female dogs as a form of birth control designed for communities where shelter facilities do not exist. Through community participation and fundraising, Cst. Kean was able to bring Dr. Samson-French and her co-workers to Labrador where one hundred and seventy six dogs received a vaccination against rabies and were dewormed and sixty three female dogs received the contraceptive implant. The program was a massive success.

Cst. Kean's tremendous initiative and efficiency in implementing the "Dogs with No Names" program, her motivation to act to create positive change in her community, and her commitment to representing her organization with a high level of professionalism, make her the 2013 AWLE Community Service Award recipient.

#### Excellence in Performance – Constable Kate McQuaid, Nova Scotia RCMP

Cst. Kate McQuaid was the Primary Investigator for a complex eleven month Part VI (Interception of Private Communications) investigation targeting a priority organ-

ized crime group. This group was suspected to be involved in the illegal production, importation and distribution of multiple kilo levels of marihuana into Halifax. As the Primary Investigator she became highly proficient in her knowledge of Major Case Management and the use of the RCMP's Evidence & Records program for file management. She supervised the speed, flow and direction, and overall coordination of all aspects of the investigation and focused on the main goals of the operation and directed tasks to achieve a successful conclusion. During the course of the investigation Kate put in many hours of voluntary time making sure that the investigation was progressing as it should. She showed tremendous perseverance and effort going through all of the evidence collected, including thousands of intercepts, hours of video recordings, and hundreds of pages of surveillance notes to ensure all pertinent information was presented in the final disclosure package.

The takedown involved over 150 police officers from the RCMP, Halifax Regional Police and Truro Police Service. Over the life of the investigation there were 19 residential locations searched, 29 individuals arrested, 124 CDSA and Criminal Code charges laid, 8 properties restrained, 5 vehicles, 5 long guns, 21 kg dried marihuana, 2,207 marihuana plants, \$100,000 cash and \$250,000 worth of grow equipment seized. By all accounts this investigation was a complete success and unmasked the criminal activity taking place by this organized crime group.

It was Kate's superior attention to duty and extra effort that directly resulted in the success of this project. She is the commendable recipient of the Excellence in Performance Award.

#### Leadership Award - Sergeant Leanne MacDonald,

Nova Scotia RCMP Sgt. Leanne MacDonald is the Operations NCO of Windsor RCMP Detachment and is responsible for all operational policing activities within the district from both an enforcement and community policing perspective, including employee development and providing supervision and mentoring. Upon her arrival in Windsor, Leanne was faced with several challenges involving morale, office engagement, and operations. Coming out of an administrative role, Sgt. MacDonald took it upon herself to become re-acquainted with District operations, which have allowed her to work with members and not just supervise them, which proved to be a very positive influence. Steeves' "Name the Shame" group to create a video that promotes sexual harassment awareness within the school community and amongst youth in their interactions with each other. Name the Shame is a youth driven program developed by Cst. Brandy Steeves, with Cst. Foote and community stakeholders with the goal to reduce sexual harassment and abuse to this affected group through knowledge, awareness and skills. Presentations on Relationship Safety, Sexual Harassment/Assault, It's a Teen's World, and Luring have been completed at numerous junior high schools. Name the Shame has hosted three Girls Power Strength weekends consisting of presentations and workshops geared towards empowering girls to make informed decisions in their lives. One boy's weekend of The Male Experience was also held.

This timely topic has broad implications for law enforcement and this great work being done by Cst. Steeves and Cst. Foote resulted in them receiving the Team Endeayour Award.

Congratulations to all of the award recipients, who are selected by an independent committee based on nominations submitted.

In addition to the professional training and the awards presentations, delegates of the conference participated in unique networking opportunities. As well, at each conference a donation is made to the charity of choice of a conference committee; the recipient this year is Anderson House, a safe and supportive shelter for women and their children who have been physically or emotionally abused or who live in constant fear of abuse.

### RCMP Commanding Officer to recognize when the Second Man was a woman

The Second Man Award is being presented to 468 women across the country who were the wives of RCMP members working in one or two-man detachments from 1900 – 1970s. The presentation provides an opportunity to recognize their dedication and commitment to their spouses and the work of the RCMP. Each woman brings amazing stories of the priceless work they provided.

RCMP Assistant Commissioner Tracy Hardy, Commanding Officer of the RCMP in Newfoundland and Labrador, honored 22 Second Man recipients on Friday, December 20th, 2013, at RCMP Headquarters, 100 White Hills Road, St. John's.

Out of the 22 women honored, 18 were present to accept the award in person. Three ladies are deceased and their family members accepted the award on their behalf. One could not make it to the presentation.

In October 2010, the previous RCMP Commissioner, William Elliott, approved the creation of a form of recognition for the wives of RCMP members who served from the 1900's to the 1970's, and whose contributions are chronicled in a book entitled, "When the Second Man was a Woman" by Ruth Lee-Knight. The RCMP Veterans' Association National Office in Ottawa was responsible for communicating with veterans across the country to solicit nominations with a deadline of February 28, 2013.

Across Canada, 468 recipients were identified and each recipient has, or will, receive a broach in the shape of the RCMP crest and a certificate of appreciation from the Commissioner.

The women were ultimately unpaid members who answered phones, searched female prisoners, and provided prisoner meals. They often used their homes as a hotel for visiting senior officers; court Judges, doctors and nurses to whom they also provided meals and entertainment. All of these tasks were done in very remote locations with inadequate housing and growing families of their own to which they also had to tend. They provided these services out of loyalty to their husbands who were stationed by the RCMP to various areas of the country, with each location bringing their own unique challenges.

#### RCMP Officers Receive Bravery Award

September 10, 2013 the Honourable Nick McGrath, Minister of Service NL and Minister Responsible for Labrador Affairs, presented two RCMP members with the Newfoundland and Labrador Bravery Award.

Corporal Denise Roussel and Sergeant Jagdeep Soin, received the Award at a ceremony in Hopedale, NL, for their role in an incident that occurred in 2001 in that community.

On February 9, 2001, Corporal Roussel and Sergeant Soin, who were both constables at the time, had been called to a residence in Hopedale. While they were trying to diffuse a volatile situation, the adult occupant lit the residence on fire. The two police officers, the adult and two children were inside the house when it happened. Corporal Roussel was able to escape by breaking a window and, in doing so, eliminated the vacuum created by the fire. Sergeant Soin was then able to escape via the front entrance, but the adult and two children remained in the residence.

Despite both officers having sustained burns, they continued their efforts to render assistance to those remaining inside the house. Sergeant Soin and bystander Nancy Tuglavina climbed onto a ledge of the burning home using a small ladder to attempt to break an upstairs window to rescue the occupants. At this time, the adult and the two children escaped the home. The three occupants, having sustained severe burns, were immediately brought to the medical clinic for treatment, but all were able to survive their injuries. Sergeant Soin and Corporal Roussel were also treated for their injuries.

Sergeant Soin, Corporal Roussel and Ms. Nancy Tuglavina received the award for their role in the incident. The Newfoundland and Labrador Bravery Award was established in 1984 under the authority of the Bravery Award Act, to recognize citizens of the province who have risked their lives and safety to render aid to another person.

Corporal Roussel is now serving in New Brunswick. Sgt. Soin is serving in Ottawa.

#### Friendly Manitoba Hosting the International Association of Women Police Training Conference in 2014

Many Canadians are familiar with the various slogans that appear on our country's license plates. The "Friendly Manitoba" slogan on our Province's license plate accurately describes the experiences many visitors have when they visit Manitoba. The warm hospitality and friendly nature of our citizens is legendary. Back in 2006, after returning from the IAWP conference in Saskatoon, a few Manitoba police officers began to talk among themselves





saying that "Friendly Manitoba" would be a great place to host this international conference.

After many years of planning, Manitoba will take centre stage in the fall of 2014, when the Winnipeg Police Service, RCMP (Manitoba) and the Brandon Police Service will host the 52<sup>nd</sup> Annual International Association of Women Police Training Conference from Sunday, September 28<sup>th</sup> to Thursday, October 2<sup>nd</sup>, 2014 in Winnipeg at the historic Fort Garry Hotel, Spa and Conference Centre.

The conference theme - The Strength of Many; Embracing Human Rights will raise the awareness of the intricate relationship between human rights

and policing. A number of milestones will be recognized during our conference including the 40<sup>th</sup> anniversary of women serving as RCMP members, the United Nations resolution 1325 to reach 20% female peace keepers by 2014 and our bilingual heritage within Manitoba will be celebrated by offering French language sessions for the first time in the conference history. We will honour fallen officers during the National Police and Peace Officers Memorial Service during our Parade of Nations at the Manitoba Legislative Grounds as our conference begins on Sunday September 28<sup>th</sup>, 2014. The Opening Parade of Nations will see members gather on



Sunday morning outside of the Fort Garry Hotel their full dress uniforms as they march on Broadway Avenue to the Manitoba Legislature where the memorial service will take place. This will be a definite highlight, as one can imagine, seeing hundreds of women police officers dressed in their formal uniforms marching through the streets of Winnipeg. I can't see a better way than this to raise the profile of IAWP!

The conference's training sessions will begin on Monday morning, as we will honour the IAWP International Scholarship Recipient with a scholarship breakfast. Our keynote speaker, Right Honourable Michaelle Jean, former Governor General of Canada will open our conference. She will share her experiences from growing up in Haiti, to immigrating to Canada with her family fleeing the dictatorial regime to becoming Canada's Governor General and how education has been instrumental in achieving her life goals. As the current UNESCO Special Envoy for Haiti, Madame Jean continues to empower young people to strive for excellence and in February 2012, she became the Chancellor of the University of Ottawa.

Throughout the week, our training programming focus will be on the three main streams of learning; leadership, wellness and human rights, specifically in areas of human trafficking, sex tourism, and gender based crimes. Some of the confirmed speakers are social advocate and a survivor of human trafficking, Timea Nagy who was born in Budapest, Hungary. Ms Nagy will shared her incredible story of survival when she was kidnapped, controlled and forced to work as a sex trade worker in Toronto more than fourteen years ago and Staff Sergeant Chris Scott of Kingston Police Department who will provide a review of the Shafia murder investigation where four women were murdered by their family members to uphold their family honour along with Superintendent Shanin Mehidizadeh, RCMP-Manitoba who was brought into the investigation to interrogate the subjects in Farsi. He will also discuss strategies he developed to "get the answers in the box". In the leadership stream, Chief Janee Harteau of Minneapolis Police Department's first female Chief will discuss skills leaders need in the 21st century and retired RCMP Commissioner Bev Busson will talk about how things have changed since she began her career with the RCMP forty years ago and how the skills she learned over that time are still necessary for our leaders of today and for tomorrow. And finally in the wellness stream, motivational speaker, Linda Edgecombe will have participants laughing and learning as she speaks on how we can get the best work/life balance out of our fast paced lives in today's environment. This is just a sample of the diversity of speakers that will be presenting at IAWP 2014. Please consult our website www.iawp2014.org for more information as we get closer to September 2014.

Another first at IAWP 2014 will be a two day Future Women in Law Enforcement conference aimed at young women in their senior year of high school.
