#### **Chief Leanne Fitch**



As of Monday June 10, 2019, Chief Leanne Fitch has retired from the Fredericton Police Force. Leanne Fitch was appointed to the position of Chief of Police for the Fredericton Police Force in June 2013 after serving one year as Acting Chief and seven years as Deputy Chief. Leanne, Atlantic Canada's first female Municipal chief and Fredericton's first female police chief retired after 34 years' service to policing.

Chief Fitch has often spoken of her parents and her father's service with the RCMP. She acknowledges that policing was not his first choice for her however he was certainly very proud when she graduated from Police College. Her father did not discourage her choice, as both her parents taught her to believe that she could do anything, his fear was in the uncertainty and hardships of the career that she would face. Having been exposed to the difficulties of policing he was certainly aware of the possible challenges.

Leanne joined policing at a time that saw very few women in the profession. In fact when she joined Fredericton Police she was one of five women in the force at the time. Leanne has certainly never been one to shy away from a challenge nor stick with status quo. She believed it was important to do your best, to have people look at your work versus your gender. It is that mindset that has seen her become a role model for other young women who have chosen to become police officers. It is in that vein that she has accomplished so much in her professional career and in her volunteering.

Chief Fitch was named officer of the year for both the Atlantic Women in Law Enforcement (AWLE) and the International Association of Women Police (IAWP) in 2002 and 2003 respectively. She has earned her Police Officers'

Exemplary Service medal from the Government of Canada, the Queen's Diamond Jubilee medal and the Member of the Order of Merit for the Police Forces (M.O.M) from the Governor General of Canada.

Leanne was a member of the Canadian Association of Chiefs of Police (CACP) and International Association of Chiefs of Police (IACP) and member and former executive board member of AWLE and the Atlantic Regional Coordinator for IAWP.

Chief Fitch has served as Aide De Camp for three Lieutenant Governors of New Brunswick and served as Vice President and President of Fredericton Therapeutic Riding Association. She has been a community volunteer throughout her career and supports a variety of not-for-profit organizations.

Chief Fitch has had a very distinguished career, full of challenges, good times, wonderful colleagues and the best of friends. She has achieved academic success and has been published. It is difficult to encapsulate everything that she has accomplished in a few words.

Although retiring Leanne will start as vice chair-person of the RCMP Interim Management Advisory Board in the fall of 2019. The Board will look at strengthening RCMP management and improve members' mental health.

The Executive of AWLE would like to congratulate Chief Fitch on her much deserved retirement. Leanne, we wish you good health and great things in whatever the future holds.



# Brown recommended as Fredericton's new Police Chief

Roger L. Brown, former Commanding Officer and Assistant Commissioner with RCMP "J" Division in Fredericton, has been recommended as Fredericton's new Police Chief.

The recommendation, which follows an extensive cross-Canada search process, was made to City Council and endorsed at their Council-in-Committee meeting on April 15, 2019. His three-year (renewable) appointment will take effect June 11, 2019. He will replace current Fredericton Police Chief Leanne Fitch, who will retire on June 10, 2019 after a distinguished policing career spanning more than three decades.



"I am confident that Mr. Brown is bringing the right combination of skills and experience to lead the talented women and men who work at the Fredericton Police Force," said Mayor Mike O'Brien. "On behalf of my colleagues on Fredericton City Council, I extend a warm welcome to Mr. Brown. We look forward to working with and getting to know him better after he assumes his new leadership role with us."

"I am looking forward to working alongside the employees of the Fredericton Police Force, the rest of the team at the City of Fredericton, and the citizens in our community," said Brown. "I feel very fortunate to have been afforded this unique leadership opportunity."

Brown has 36 years of policing experience with the Royal Canadian Mounted Police (RCMP), starting out as a constable in Rivière-du-Loup, QC and rising through the ranks to assume the top post at RCMP "J" Division. He retired from that position in 2016.

His career has taken him across Canada. He has served in a variety of positions, progressing through a number of senior level positions in the areas of human resources, protective policing, training, and operations. Most recently, he has been speaking across the country about the mental health issues facing first responders and the shift in leadership required to address the matter.

During his time as Commanding Officer at "J" Division, he had lead of the division during the murder of three Mounties in Moncton, shale gas demonstrations, and high profile mental health issues. He implemented a province-wide mental health strategy and also developed and implemented a sustainable core services model aligned with current fiscal restraints. He is fluently bilingual.

His education includes general and advanced police studies at the Canadian Police College, Ottawa, ON; a Diploma in Adult Education from St. Francis Xavier University, Antigonish, NS; course work at the University of Waterloo, ON and the University of Regina, SK; as well as a Human Resources Certificate from the University of Toronto's Rothman School of Business, Toronto, ON.

Among his many achievements, Brown was selected by the Canadian Association of Mental Health (CAMH) in 2017 as one of 150 leading Canadians in mental health. He was the 2012 recipient of the Michelle C. Comeau Leadership Award, recognizing Federal government executives who always go the extra mile in driving successful human resource strategies. In 2012, he was also the recipient of the Officer of the Order of Merit for Police.

**Update:** Roger Brown was sworn in as Chief of Fredericton Police Force on June 12. AWLE extends their congratulations to Chief Brown and is looking forward to working with him.


The gala is a night you'll never forget. Members attend in dress uniform and each service lines up to be

#### Sergeant Nancy Rudback, Member of the Order of Merit

Sergeant Nancy Rudback was accepted to the Order of Merit of the Police Forces for her exceptional service with Halifax Regional Police which has brought her both national and international recognition. Sergeant Rudback has distinguished herself by being a mentor, a trainer and as a trail blazer in policing. She is also an active member in the community volunteering her time with a number of committees and community initiatives.

Sergeant Rudback's career began in 1989 at a time when females were in the vast minority and in fact when she began with HRP the number of female officers doubled from 4 to 8. She was one of the first female officers in Halifax to become an Officer Safety Trainer and the first female instructor for dry and live firearm



training. She distinguished herself in this role by supporting many female officers through training and by ensuring training programs were properly developed for the female members. Sergeant Rudback has also served as a coach officer providing leadership and mentoring for newly hired police officers.

In 2004, Sergeant Rudback volunteered for a United Nations Peace Keeping Mission in Sierra Leone, West Africa. She spent 9 months with the Sierra Leone National Police (SLP) as a trainer and mentor. She also served as the Family Support Unit Liaison Officer where she demonstrated her commitment and compassion to the international community of Sierra Leone.



Sergeant Rudback has served as an Aide de Camp for the past nine years with the Lieutenant Governor of Nova Scotia. Sergeant Rudback was one of the first four female officers to be promoted to the rank of Sergeant with Halifax Regional Police.

Sergeant Rudback has been distinguished as the recipient of the United Nations Assistance Mission in Sierra Leone Medal, the Canadian Peace Keeping Medal, the Police Exemplary Service Medal, the Nova Scotia Long Service Medal, the Queen's Jubilee Medal and received an HRP Commendation for a volunteer position with the Honour Guard and a Halifax Regional Police Superintendent Compliment for Leadership while working in the Vice Unit. In 2014, Sergeant Rudback received the Mentoring Award from the Atlantic Women in Law Enforcement (AWLE). Then in 2015 her accomplishments were celebrated internationally when she received the International Association of Women Police (IAWP) Mentoring Award in Cardiff, Wales at the IAWP Centennial Celebration.

Sergeant Rudback is a graduate of The Nova Scotia's Teacher College with an Associate of Education with a major in Physical Education. She is also a graduate of Mount Saint Vincent University with a Bachelor of Education minoring in Special Education. She has made a commitment to further her education completing police related courses offered by the Atlantic Police Academy and the Canadian Police College. She has also completed the Police Leadership Certificate with concentrations in Supervisory Skills and Administration from Dalhousie University - Henson College.

She is an example of a law enforcement officer who has distinguished herself and brought credit to her Organization.

Born in Grand Bank. Newfoundland and Labrador. Her Honour Judy May Foote (née Crowley) attended John Burke High School in Grand Bank and is a graduate of Memorial University. Her Honour is a former teacher, journalist and communications director and

served in the House of Assembly and the Parliament

of Canada. She holds a Bachelor of Arts and a Bachelor of Education from Memorial University and an Honours Diploma in Radio, Television, Journalism Arts from Lambton College.

Prior to serving in politics Her Honour taught school in Grand Bank and St. John's before working in television journalism with the CBC's public affairs program "Here & Now"; was the Director of University Relations with Memorial University; and, the Director of Communications for the Office of the Premier, Newfoundland and Labrador.

#### Join our AWLE Executive Team

The following positions are up for election at our Annual General Meeting to be held at our 27<sup>th</sup> Annual AWLE Conference on Thursday October 17, 2019:

#### **AWLE President**

The President shall be the chief executive and operating officer of the Corporation and, subject to the authority of the Board shall have general supervision of the business of the Corporation, and shall without limiting the generality of the foregoing:

- (1) Preside at all meetings of the Board or committees of the Board.
- (2) Appoint standing committees and special committees.
- (3) Act as member ex-officio of all committees.
- (4) Coordinate committees.
- (5) Submit articles to the editor of the Corporation's official publication, *The Notebook*.
- (6) Submit articles to the webmaster of the Corporation's official website, <u>www.awle.org</u>, and ensure accuracy of website content.
- (7) Coordinate award nomination procedure including soliciting nominations from law enforcement agencies, in the Atlantic provinces, providing nomination packages to the Awards Coordinator, and contacting nominees and nominators after award recipients have been selected.
- (8) Preside over awards ceremony during annual conference with the Awards Coordinator.
- (9) The President, shall also be the <u>Professional Association Liaison</u>, and shall perform among other things, the following functions:
  - (a) Establish contacts and introduce the object of the Corporation to all professional law enforcement associations, unions, and affiliates within the Atlantic Provinces.
  - (b) Respond to enquiries from various sources, including members, law enforcement agencies, and International Association of Women Police.
  - (c) Submit annual spring and fall affiliate reports to the International Association of Women Police.
  - (d) Represent the Corporation at International Association of Women Police functions such as annual conferences and board meetings.
- (10) Attend all AWLE Executive Meetings and AWLE Conferences, wherever possible

The President may delegate responsibility for these duties as required.

#### **AWLE Vice President**

- (1) The Vice-President, if any, shall have all of the power and authority, and shall perform all of the duties of the President in the absence of, disability or refusal to act of the President. In addition, the Vice-President shall assist the President and the Board, as necessary, in the performance of Board duties.
- (2) Attend all AWLE Executive Meetings and AWLE Conferences, wherever possible.



#### **AWLE Secretary**

The Secretary, if any, shall perform, among other things, the following:

- (1) Maintain such books, documents and papers as the Board shall determine.
- (2) Attend and keep detailed minutes of all meetings of the Board and members and prepare board Meeting Agendas.
- (3) (a) Transcribe minutes and send copies to all members of the board within 30 days after the meeting.
  - (b) Create task lists that require actioning of the board members from meetings and forward to all members of the board within 30 days after the meeting.
- (4) Receive correspondence and other materials for the Corporation and maintain them in orderly files. Respond to correspondence as requested by the President and/or Board.
- (5) Assure that the records and files are available at meetings as may be needed or requested for reference. Advise the President and Board as requested during meetings.
- (6) Present minutes for approval at Members and Board meetings either in writing or as read, unless otherwise waived by a majority of the Members or of the Board, as the case may be.
- (7) Provide the Board with a complete and current listing of addresses and phone numbers of all Board and committee members and updates as necessary.
- (8) Will fulfill and perform the function as the <u>Historian</u>:
  - a. Maintain the archives of the Corporation
  - b. Compile pertinent material of interest and/or concern to the Corporation.
  - c. Upon providing a written request to the President, present material of interest, to members at meetings and conferences.
- (9) Attendall AWLE Executive Meetings and AWLE Conferences, whenever possible.

#### **AWLE Treasurer**

The Treasurer, if any, shall perform, among other things, the following functions:

- (1) Maintain custody of all funds, property and securities of the Corporation.
- (2) Submit record to two (2) appointed trustees annually, to review and verify spending accountability of the Corporation
- (3) Endorse for collections, cheques, notes and other obligations and deposit in the bank of the Corporation.
- (4) Sign receipts, vouchers, cheques, bills of exchange and promissory notes issued by the Corporation.

While cannabis (marijuana) has recently been legalized and strictly regulated domestically in Canada, it is still illegal to cross the border with cannabis or any products containing it.

- You cannot transport cannabis across the border, even when travelling to or returning from a country or state which has legalized or decriminalized cannabis.
- Declare cannabis or products containing cannabis to the Canada Border Services Agency (CBSA) when entering Canada if you happen to have it with you.
- Individuals who do not declare cannabis products to the CBSA can face enforcement action, including arrest and prosecution.
- Holding a medical authorization for use of cannabis in any country, including Canada, does not grant the ability to take cannabis into or out of Canada. In rare and exceptional circumstances, Health Canada may authorize an individual to bring cannabis across international borders for medical or scientific purposes on a case-by-case basis.
